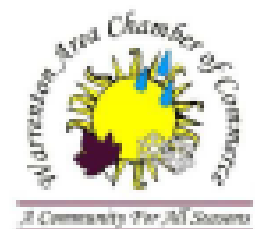

Dear Potential Exhibitor,

The Warrenton Area Chamber of Commerce is pleased to announce the **13th Annual Home and Garden Show - 2012**. This event has continued to grow and improve each year and we invite your participation to continue this trend. We feel that we have made some very positive changes this year based on the vendor feedback from last year's event.

The 2012 Home and Garden Show event is scheduled for Saturday, **April 21st, 9:00 am – 3:00 pm** and **Sunday, April 22nd, 11:00 am – 3:00 pm** at the Missouri Army National Guard Armory located on the North Outer Road in Warrenton - #1 Armory Road (near Moser's). We are again pleased about the fact that we will be able to accommodate our booths under one roof and still have plenty of space outside for those booths that need to have an outdoor venue. We will again be utilizing the front parking lot for greater exposure. Visibility from I-70 is a definite plus for this event and we are excited to be in this location again.

There will be cash prizes for 1st, 2nd, and 3rd Best Looking Booth. In an effort to be more family friendly, we are encouraging our vendors to have an activity for kids. This is not, however, a stipulation for participating in the Home and Garden Show.

You are invited to showcase your business, organization, club or church at the Home and Garden Show event by having a booth. We have included an application listing booth sizes and pricing. The pricing remains the same as last year. **If you need electricity, there will be a \$25 charge (up to 400 watts).** Concession booths will be located outside in the fenced area. **All concessions must be approved by the committee and coordinated with other vendors so there is no duplication of food (excluding chips and beverages).**

You are welcome to share your booth with another business, if you like. If either business is a non-chamber member, however, you will be expected to pay the non-chamber rate. You are responsible for finding your own partner business. **Your application with fee, security deposit and a signed hold-harmless agreement must be in the Chamber office by April 6, 2012.** While booth spaces may still be available after this date, they will be on a first come, first served basis. Please remember that your security deposit of \$50.00 (a separate check) will be returned at the end of the show if the following criteria are met: 1) You remain for the duration of the show. 2) The booth remains clean/swept. Booth space availability is limited so your expedient reply is necessary.

Tables will NOT be provided this year. You are responsible for bringing your own tables.
